AN ORDINANCE APPROVING A VARIATION IN ACCESSORY BUILDING MAXIMUM SQUARE FOOTAGE OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 2003 TITLE 10, ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in the maximum square footage for an accessory building of 1,000 square feet to allow for an accessory building that is 1,600 square feet.

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on November 11, 2004 at 7:00 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said Zoning Board of Appeals did hold a hearing as required by the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois and did not recommend that said petition for variation in the maximum square feet to allow for an accessory building that is 1,600 square feet., and

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the hereinafter described property have been completed,

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

SECTION 1. As to the real estate described as follows:

Lots 11, and 12 in Block 129 in the original Town of LeRoy, Mclean County, Illinois. (909 N. Barnett St.)

Requiring a maximum square footage of 1,000 sq. ft. is hereby granted a variation from the required maximum sq. ft. to allow for the construction of an accessory building that is 1,600 sq. ft.
