AN ORDINANCE APPROVING A VARIATION IN FRONT YARD SETBACKS OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 2003 TITLE 10, ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking from 25 feet to 10 feet a variance of 15 feet from the original 25 feet to 10 feet in the front yard setback,

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on June 7, 2007 at 7:00 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said Zoning Board of Appeals did hold a hearing as required by the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois and did recommend that said petition for variation of 15 feet from the original 25 feet to 10 feet in the front yard setback to allow for a privacy fence, and

Requiring a minimum setback of 25 feet to 10 feet is hereby granted a variation of 15 feet from the original 25 feet to 10 feet from the required minimum setback to allow for a privacy fence.
