#### **ORDINANCE NO. 11-07-02-51**

AN ORDINANCE APPROVING A VARIATION OF ACCESSORY BUILDING HEIGHT REQUIREMENTS AND SIDE SETBACK REQUIREMENTS OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 2003 TITLE 10-ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in accessory building height requirements of 15 feet maximum to a total height not to exceed 22 feet AND side setback requirements of 10 feet to 2 feet within the R-1, 1 & 2 Family Residential district, to allow for the construction of a 24 feet by 30 feet detached garage located at the residence commonly referred to as 716 E. Center Street, City of Le Roy, McLean County, Illinois; and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on July 7, 2011 at 7:00 p.m. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances; and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois, to approve said petition for a variation in building height requirements of 15 feet maximum to a total height not to exceed 22 feet AND to approve a reduction in side yard setback requirement of 10 feet to no less than 5 feet in exception of 2 feet side yard setback requested by petitioner; and

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the zoning regulations regarding the hereinafter described property have been completed,

**NOW, THEREFORE, BE IT ORDAINED,** by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

# **Section 1.** The real estate described as follows:

Lot 6 and W ½ Lot 5 of Block 1 within Moorehouse & Barleys Addition & W66' E554.14' of Outlot A within Crumbaughs Cherry Street Addition commonly referred to as 716 E. Center Street in the City of Le Roy, McLean County, Illinois.

Is hereby granted a variation from the City of Le Roy Municipal Code accessory building height requirement of 15 feet to a maximum accessory building height of 22 feet AND secondly, a reduction in the 10 feet in side yard setback requirement to no less than 5 feet of side yard setback so as to allow construction of a 24 feet by 30 feet detached garage.
