AN ORDINANCE APPROVING A VARIATION OF CORNER YARD SETBACK REQUIREMENTS OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 2003 TITLE 10, ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in side yard setback requirements in the C-2, Commercial District for a Non-Conforming residential dwelling from the required 25 feet corner yard setback to a setback of 3 feet to allow construction of a 6' privacy fence; and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on July 9, 2015 at 7:00 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois, approving said petition for a variation in corner yard setback from the required 25 feet corner yard setback to a setback of 3 feet to allow the construction of a 6' privacy fence; and

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the hereinafter described property have been completed,

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

SECTION 1. As to the real estate described as follows:

Lots 9, 10, 11 & 12, Block 68, commonly referred to as 602 N. Walnut Street in the City of Le Roy, McLean County, Illinois.

Is hereby granted a variation from the required 25 feet corner yard setback to a 3 feet corner yard setback for the construction of a 6' privacy fence.
