ORDINANCE NO. 438

AN ORDINANCE APPROVING A VARIATION OF SETBACK REQUIREMENTS OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 (as amended), CHAPTER 21-ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of LeRoy, in regard to premises described hereinafter, said petition seeking a variance of the front-yard setback requirements from the required 25 foot setback for such front-yards to a setback of only 11.75 feet, and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of LeRoy, Illinois, on May 7, 1992, at 7:00 p.m., at the City Hall, LeRoy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of LeRoy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said zoning board of appeals did recommend to the City Council of the City of LeRoy, Illinois, that said petition for variation in front-yard setback requirements be approved, and

WHEREAS, all things required by law and ordinance to be done in regard to the rezoning of the hereinafter described property have been completed.

NOW. THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

SECTION 1. The real estate described as follows:

Lot 1 in Block 3 in the Original Town of LeRoy, McLean County, Ilinois (commonly known as 410 North Main Street, LeRoy, Illinois),

requiring a front-yard setback along the East property line is hereby granted a variation from the required front-yard setback of 25 feet to a front-yard setback requirement of 11.75 feet.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
