ORDINANCE NO. 507

AN ORDINANCE APPROVING A VARIATION OF SETBACK REQUIREMENTS OF THE MUNICIPAL CODE, LEROY, ILLINOIS, 1975 (as amended) CHAPTER 21 - ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of LeRoy, in regard to premises described hereinafter, said petition seeking a variance of the front-yard setback requirements from the required 25 foot setback, and a variance in the side-yard setback requirements from the required 10 foot setback, thus making a front-yard variance to a setback of only 22 feet, and a side-yard variance to a setback of only 6 feet, for the construction of an 8 foot cyclone-type fence, and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of LeRoy, on July 19, 1993, at 7:20 p.m., at the City Hall, LeRoy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of LeRoy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said zoning board of appeals did recommend to the City Council of the City of LeRoy, Illinois, that said petition for variations in front-yard and side-yard setback requirements be approved, and

WHEREAS, all things required by law and ordinance to be done in regard to the zoning of the hereinafter described property have been completed.

NOW. THEREFORE. BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. The real estate described as follows:

Lot 6, in the Subdivision of the South East 1/4 of Section 21, Township 22 North, Range 4 East of the Third Principal Meridian, in the City of LeRoy, EXCEPT the East 50 feet, in McLean County, Illinois (commonly known as 700 East Pine Street, LeRoy, Illinois),

located in the R-1, One- and Two- Family Residential District of the City of LeRoy, McLean County, Illinois, is required by ordinance to maintain a 25 foot front yard and 10 foot side yards, and a petition has been received by the City of LeRoy, and a recommendation made by the Zoning Board of Appeals of the City of LeRoy, said petition, and the recommendation thereon, being to the effect that a variance permitting a 22 foot front yard, thus being a 3 foot variance in the front yard requirements under the aforesaid zoning district regulations, and being to the effect that a variance permitting a 6 foot side yard on the east side of subject property, thus being a 4 foot variance in the side yard requirements under the aforesaid zoning district regulations, be approved, upon due consideration, the said variations are hereby granted from the front yard setback requirements and side-yard setback requirements of the R-1, One- and Two- Family Residential District of the City of LeRoy, McLean County, Illinois, for the hereindescribed real estate, to permit the construction of a chain-link type fence not higher than eight feet and not closer to the lot lines than permitted by the aforesaid variance.

<u>Section 2.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
