AN ORDINANCE APPROVING A VARIATION OF SETBACK REQUIREMENTS OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 (as amended) CHAPTER 21 - ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance of the front yard setback requirement from the required 25 foot setback for such front yard to a setback of only 0 feet.
