ORDINANCE NO. 635

AN ORDINANCE APPROVING A VARIATION OF MINIMUM STREET FRONTAGE REQUIREMENTS OF THE MUNICIPAL CODE, LEROY, ILLINOIS, 1975 (as amended), CHAPTER 21 - ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was recieved by the City of LeRoy, in regard to premises described hereinafter, said petition seeking a variance of the minimum street frontage requirements from the required 44 feet of street frontage, to a minimum of 35 feet; and,

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of LeRoy, Illinois on October 12, 1995, at 7:36 p.m., at the City Hall, LeRoy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of LeRoy, McLean County, Illinois, to consider the aforesaid petition, after due notice was given in accordance with all applicable laws and ordinances; and

WHEREAS, the Zoning Board of Appeals did recommend to the City Council of the City of LeRoy, Illinois, that said petition for variation of minimum street frontage requirements be approved; and

WHEREAS, all things required by law and by ordinance to be done in regard to the variation of the hereinafter described property have been completed;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

<u>Section 1</u>. The real estate described as follows:

Lot 3, Except 114.5 feet off the east side thereof, Lot 4 Except beginning at the North East corner of said Lot 4; thence South 165 feet on the East line of said Lot 4; thence West 75 feet on a line parallel with the North line of said Lot 4; thence 165 feet on a line parallel with the East line of the said Lot 4 to the North line of the said Lot 4; Thence East 75 feet on the north line of the said Lot 4 to the point of beginning, all being situated in the subdvision of Lot 7 in the South West 1/4 of Section 21, Township 22 North, Range 4 East of the Third Principal Meridian, McLean County, Illinois (commonly known as 204 West Vine Street, LeRoy, Illinois),

requiring a minimum street frontage of 44 feet is hereby granted a variation from the required aforesaid street frontage to a minimum required street frontage of 35 feet.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
