AN ORDINANCE APPROVING A VARIATION OF SIDE YARD SETBACK REQUIREMENTS OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 (as amended) CHAPTER 21 - ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in side yard setback from the required 10' setback to a 5' setback to allow for the construction of a garage.
