AN ORDINANCE AMENDING TITLE 3; CHAPTER 3, CHAPTER 4 AND CHAPTER 5 OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the fees for Business and License Regulations; and
