AN ORDINANCE AMENDING TITLE 3, CHAPTER 2B, SECTION 4 OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the fees for Hotel/Motel Tax; and

WHEREAS, the Mayor and City Council of the City of Le Roy have determined that said fees shall be increased, being in the best interest of the city and its residents; and

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the hereinafter described property have been completed,

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

SECTION 1: That Title 3, Business and License Regulations, of the municipal code of Le Roy, Illinois 2003 Chapter 2B Section 4 is hereby amended by substitution of the figure five percent (5%) in place of three percent (3%).

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
