ORDINANCE NO. 257

AN ORDINANCE PROVIDING FOR THE SUBMISSION TO THE VOTERS OF THE CITY OF LEROY, MC LEAN COUNTY, ILLINOIS, THE QUESTION OF ISSUING NOT TO EXCEED \$ 295,000.00 OF MUNICIPAL GENERAL OBLIGATION BONDS AT A REGULAR ELECTION TO BE HELD IN AND FOR SAID CITY ON THE 18th DAY OF MARCH, 1986.

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that the financial resources of the City, including all property taxes presently being levied, are not sufficient to provide for the reasonable cost of extending the sewer collection system of the City south under Federal Interstate Route 74 and thence westerly to the site of the LeRoy Auto/Truck Plaza and southerly to provide a point at which future extensions of the system in a further southerly direction to service the Golden Eagle Estates Subdivision and other territory within the municipal limits within that vicinity may be connected, and

WHEREAS, the Mayor and City Council of the City of LeRoy deem it advisable and in the best interests of the public and of the City of LeRoy that such extension of the City sewage collection system be made as soon as provision for the same may reasonably be made, and

WHEREAS, the Mayor and City Council of the City of LeRoy have heretofore estimated the cost of constructing portions of the expansion of the sewage collection system beginning at the City Sewage Treatment Plant and running in a generally southerly direction crossing under Federal Interstate Route 74 and then in a westerly direction to a location on or about the LeRoy Auto/Truck Plaza site, and a second leg running from south of Federal Interstate Route 74 in a generally southerly direction to a point near the intersection of Salt Creek Road and Bicentennial Drive, all in the City of LeRoy, McLean County, Illinois, and

WHEREAS, funds are not available for the purpose of constructing said expansion in the sewer system, as hereinabove described, and it will therefore be necessary to borrow money and in evidence thereof to issue bonds of said City, and before bonds can be issued the question of issuing said bonds must be submitted to the electors of said City and approved by a majority of the electors yoting on said question at an election called for that purpose,

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled as follows:

Section 1. That it is hereby determined to be in the best interests of the City of LeRoy and its citizens to construct an expansion of the existing sewage collection system as said expansion is outlined in proposed construction plans submitted to the City by the city engineer, said plans being generally described as "Route 74 South Sanitary Sewer Extension Divisions A, A-1, B, B-1, and as said sewage collection system expansion is previously described in the preambles of this ordinance, and for that purpose it will be necessary that City borrow money and in evidence thereof issue the bonds of said City.

Section 2. That there be borrowed by, for and on behalf of said City of LeRoy not to exceed the sum of \$ 295,000.00 for the purpose of paying the cost of constructing the expansion of said sewage collection system in and for said City and that in eyidence of said loan negotiable bonds of said City be issued, and that said bonds be appropriately designated general obligation bonds of the City of LeRoy and that said bonds shall mature in not more than twenty years from the date of issue, shall bear interest at a rate not to exceed the greater of nine per cent per annum or one hundred twenty-five per cent of the rate for the most recent date shown in the 20 G. O. Bonds Index of average municipal bond yields as published in the most recent edition of The Bond Buyer, published in New York. New York, at the time the contract is made for the sale of the bonds, and shall have such other qualifications, provisions and conditions as set forth in the ordinance pursuant to which the aforesaid bonds are issued, at the discretion of the City Council of the City of LeRoy, Illinois. Such bonds shall bear interest at the lawful rate and shall be payable at such time or times as the City Council may determine upon adoption of an ordinance to issue the aforesaid bonds after a favorable yote at the aforesaid referendum.

Section 4. That said election shall be held in the several election precincts of said City heretofore established as election precincts for all City elections and the polling place for each shall be as follows:

Precinct Number 1 - Being also designated as McLean County Precinct Empire 15-01, in the City of LeRoy and Town of Empire, County of McLean, State of Illinois. Polling place being as designated for Precinct Number Empire 15-01, Empire, Township, McLean County, Illinois.

Precinct Number 2 - Being also designated as McLean County Precinct Empire 15-02, in the City of LeRoy and Town of Empire, County of McLean, State of Illinois. Polling place being as designated for Precinct Number Empire 15-02, Empire Township, McLean County, Illinois.

Precinct Number 3 - Being also designated as McLean County Precinct Empire 15-03, in the City of LeRoy and Town of Empire, County of McLean, State of Illinois. Polling place being as designated for Precinct Number Empire, 15-03, Empire Township, McLean County, Illinois.

Section 5. That the City Clerk of the City of LeRoy be and is hereby ordered and directed to take such action as may be necessary, including making appropriate request of the County Clerk of McLean County, Illinois, to see that notice of said election be given by requesting publication of said notice in accordance with the laws of the State of Illinois pertaining to same, and by posting notice of said election, as required by the applicable laws. Said notice to be published and posted, as required, shall be in substantially the following form:

The polls at said election will be open at 6:00 a.m., Central Standard Time, and will be closed at 7:00 p.m., Central Standard Time, on the date of the election. All persons qualified to vote at regular City elections or qualified to vote on said question must vote at the polling places designated for the election precinct within which they reside.

Section 6. The judges and clerks of election shall be such as shall be hereafter designated by Jeanette Barrett, County Clerk of McLean County, Illinois, to serve as election officials and shall be designated on behalf of the Mayor and City Council of the City of LeRoy, Illinois.

Section 7. That the ballot to be used at said election for the purpose of submitting the question to the voters shall be in substantially the following form:

Shall bonds in an amount not to exceed \$ 295,000.00 be issued by the City of LeRoy for the purpose of paying the cost of constructing an expansion of the existing City of LeRoy sewage collection system, said expansion being generally south from the City Sewage Treatment Plant under Federal Interstate Route 1-74. and thence in two branches, being one in a southerly direction and the other in a westerly direction, as said expansion is proposed in construction plans titled Route 74 South Sanitary Sewer Extension Divisions A, A-1, B, B-1, said bonds bearing interest at a rate of not to exceed the greater of nine per cent per annum or one hundred twenty-five per cent of the rate for the most recent date shown in the 20 G. O. Bonds Index of average municipal bond yields as published in the most recent edition of The Bond Buyer, published in New York, New York, at the time the contract is made for the sale of the bonds?
