ORDINANCE NO. 00-09-01-50

AN ORDINANCE EXTENDING THE EXPIRATION DATE OF THE CABLE TELEVISION FRANCHISE AGREEMENT AUTHORIZING THE OPERATION OF A CABLE TELEVISION SYSTEM

WHEREAS, the City of Le Roy ("Grantor") has an agreement with Mediacom Illinois LLC ("Mediacom") as successor to Triax Cable vision, L.P., for the operation and construction of a cable television system within the City of Le Roy (the "Agreement"); and

WHEREAS, the Agreement shall be expired by its terms on or about September 4, 2000, unless Grantor and Mediacom mutually agree to extend the term of the Agreement; and

WHEREAS, Grantor and Mediacom are involved in a cable franchise renewal proceeding, which will not be concluded by that date; and

WHEREAS, Mediacom has submitted a request to Grantor for an extension of the expiration date of the Agreement until November 7, 2000:

NOW, THEREFORE, BE IT ORDAINED by the City Council of City of Le Roy as follows:

- 1. The term of the Agreement granting Mediacom permission to construct and operate a cable television system is hereby amended to expire November 7, 2000, unless Grantor and Mediacom have executed and adopted a new cable television franchise agreement prior to that date, in which case the Agreement shall expire and terminate concurrently with the effective date of said new franchise agreement.
- 2. Except as modified by Paragraph 1, all other terms, conditions, provisions and requirements of the Agreement shall remain in force and effect. Neither party waives any right it may have pursuant to the Agreement, State or Federal law.
- 3. Mediacom, if it accepts this Ordinance and the rights and obligations hereby granted, shall file with Grantor its written acceptance of this Ordinance.
- 4. This Ordinance shall be effective upon its passage, approval and publication in accordance with law.
