ORDINANCE NO. 08-06-01-10

AN ORDINANCE AMENDING TITLE 1: ADMINISTRATION, CHAPTER 8A: CITY ADMINISTRATOR, SECTION 6: POWERS AND DUTIES, SUB-SECTION 5: PURCHASES AND CONTRACTS, DEFINING RESPONSIBLE BIDDERS FOR THE CITY OF LEROY, McLEAN COUNTY, ILLINOIS

WHEREAS, Title 1: Administration, Chapter 8A: City Administrator, Section 6: Powers and Duties, Sub-section 5: Purchases and Contracts defines responsible bid requirements, and the definition needs to be expanded in the case of bidders for construction projects (construction of new facilities, renovations of current facilities or road construction projects) over \$20,000.00.

NOW, THEREFORE, BE ORDAINED, by the City of Le Roy in the County of McLean, Illinois that the following definition be added to Title 1: Administration, Chapter 8A: City Administrator, Section 6: Powers and Duties, Sub-section 5: Purchases and Contracts of the municipal code for the City of Le Roy.

- d. Responsible bidder for construction contracts means a bidder who meets all of the job specifications, the following applicable criteria, and submits evidence of such compliance.
 - 1. All applicable laws prerequisite to doing business in Illinois
 - 2. Evidence of compliance with
 - a. Federal Employer Tax Identification Number or Social Security Number (for individuals)
 - b. Provisions of Section 2000(e) of Chapter 21, Title 42 of the United States
 Code and Federal Executive Order No. 11246 as amended by Executive
 Order No. 11375 (known as the Equal Opportunity Employer provisions).
 - Certificates of insurance indicating the following coverage's: general liability, workers' compensation, completed operations, automobile, hazardous occupation and product liability.
 - 4. Subject to the provisions of paragraph 5, the bidder and all bidder's subcontractors must participate in active apprenticeship and training programs approved and registered with the United States Department of Labor's Bureau of Apprenticeship and Training for each of the trades of work contemplated under the awarded contract.

5. If a bidder complies with paragraph four above and is 5% or more higher than the lowest bidder that does not comply with paragraph 4 then the city shall select the lowest bidder. If the lowest bidder has not complied with paragraph 4 above and the next lowest bidder is less than 5% higher than the lowest bidder then the city may elect to pick the lowest bidder who has complied with paragraph 4 and is less than 5% higher than the lowest bidder.

BE IT FURTHER ORDAINED, that this amendment shall be effective prospectively and shall not impair any rights or privileges that may have accrued or otherwise existed prior to the adoption of this amendment.

BE IT FURTHER ORDAINED, that this Ordinance amendment shall be in full force and effect immediately upon its adoption.
