ORDINANCE NO. <u>657</u>

AN ORDINANCE AMENDING CHAPTER 34 - LIQUOR, SECTION 34.09 B., OF THE MUNICIPAL CODE, LEROY, ILLINOIS, 1975 (as amended).

WHEREAS, the Mayor and City Council fo the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its residents to amend the ordinance regarding regulation of sales of liquor within said City to provide a lower fee for the licensing of catering businesses to enable said businesses to supply and serve alcoholic beverages for certain types of events in the City,

NOW, THEREFORE, BE IT ORDAINED, by the City Council to the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. That Chapter 34, Liquor, of the Municipal Code of LeRoy, Illinios 1975 (as amended), Section 34.09 B., sub-section (6). (h), is hereby amended by substitution of the figures "\$100.00" in place of the figures "\$250.00" in the first line of said sub-sub-section. Said sub-subsection (h) is further amended by substitution of the figure "\$50.00" in place of the figures "\$100.00" at the beginning of the third line of said sub-sub-section.

Section 2. In all other respects the aforesaid Section 34.09 B. (6), shall continue in full force and effect.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
