ORDINANCE NO. 846

AN ORDINANCE AMENDING SECTION 34.02 LICENSE REQUIRED., OF CHAPTER 34 LIQUOR, OF THE MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS, 1975 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of LeRoy deem it to be in the best interest of the City and its residents to amend the minimum requirements to obtain liquor licenses from the City in certain instances; and

WHEREAS, 235 ILCS 5/6-11 provides that no license may be granted to any applicant for a liquor license having a location within 100 feet of any church, school other than an institution of higher learning, hospital, home for aged or indigent persons or veterans, their spouses or children, or any military or naval station,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. Section 34.02 License Required., F., of CHAPTER 34 LIQUOR, Municipal code of the City of LeRoy, Illinois, 1975 (as amended), is hereby amended by deletion of the number "150" occurring between the words "...within" and "feet...", and the number "100" is substituted therefor.

<u>Section 2</u>. All ordinances, or parts thereof, and all resolutions, or parts thereof, in conflict with this ordinance shall be and the same and are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.

Section 3. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or any liability incurred, or any cause or causes of action acquired or existing under any Act or ordinance hereby repealed as cited in Section 1 of this ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as required by law.
