ORDINANCE AUTHORIZING CONVEYANCE OF MUNICIPALLY OWNED REAL ESTATE

WHEREAS, the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, owns the following described real property:

That part of Lot 2 in the Subdivision of the Northeast Quarter of Section 27, Township 22 North, Range 4 East of the Third Principal Meridian described as follows: Beginning at a point on the North line of the Northeast Quarter of the said Section 27 a distance of 198 ft. East of the Northwest corner of the said Northeast Quarter; thence N. 89 -53'-16" E. 79.0 ft. on the North line of the said Northeast Quarter; thence S. 13 -51'-39" E. 163.54 ft.; thence S. 05 -38'-34" E. 242.27 ft.; thence S. 00 -00'-00" E. on a line parallel with the West line of the said Northeast Quarter a distance of 258.98 ft. to the South line of the said Lot 2; thence S. 89 -58'-57" W. 142.0 ft. on the South line of the said Lot 2; thence N. 00 -00'-00" W. 658.75 ft. on a line parallel with the west line of the said Northeast Quarter to the Point of Beginning containing 1.92 acres, more or less, and being situated in McLean County, Illinois,

which property is generally located adjacent to and east of Oak Grove Cemetery, in Empire Township, McLean County, Illinois, and is currently undeveloped, and owned by the City under a deed of gift to be used for recreation and other similar public purposes; and

WHEREAS, the Mayor and City Council of the City of LeRoy, Illinois, have determined that it is no longer necessary, appropriate, or in the best interests of the City of LeRoy, McLean County, Illinois, that it retain title to said real estate, and that said real estate is not required for the use of, or profitable to the City of LeRoy, and that said real estate is not capable of being utilized by the City of LeRoy for the purpose for which it was originally donated to the City, and any other use that the City would make of said property, if any other use were possible, would be in violation of the terms of the aforesaid gift; and

WHEREAS, the Mayor and City Council of the City of LeRoy, Illinois, find that there is no other use that may be reasonably made of said property by the City, and that, therefore, said property is of no benefit whatsoever to the City of LeRoy; and

WHEREAS, the Mayor and City Council of the City of LeRoy, Illinois, find that it is appropriate that said real estate be conveyed for nominal consideration to the Trustees of Oak Grove Cemetery Association for the benefit of said Association and its successors in interest for use for cemetery purposes only, and further that said conveyance be made only with the consent of M. Louise Croft, donor under the Deed of Gift to the City of LeRoy for real estate including the previously-described real estate, said Deed of Gift having been dated February 4, 1985, and

WHEREAS, the Mayor and City Council of the City of LeRoy, Illinois, find that the real estate previously described herein has no actual value or only nominal value and would prove to be a liability if the City of LeRoy were to continue to own it:

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled as follows:

Section 1. The Mayor and City Council of the City of LeRoy find as facts the recitals hereinabove set forth.

Section 2. The Mayor and City Council of the City of LeRoy hereby authorize conveyance of the real estate described in Exhibit "A" attached hereto and incorporated herein by reference and hereby direct the Mayor and City Clerk to execute the quit-claim deed, a copy of which is attached hereto as Exhibit "A," as well as any other necessary and related documents in order to accomplish the conveyance of the previously-described real estate to the Trustees of Oak Grove Cemetery Association for uses and purposes as herein previously set forth and as provided for in the provisions of the quit-claim deed, a copy of which is attached hereto as Exhibit "A."

Section 3. The City Clerk is hereby further authorized to acknowledge and attest such deed and to affix thereto the seal of the City of LeRoy, McLean County, Illinois.

Section 4. This ordinance shall be in full force and effect from and after its passage, by vote of at least three-fourths of the corporate authorities now holding office, and approval in the manner provided by law, and publication in pamphlet form.

NOTE: The/deed from Martin and Mary Howard to the Trustees of Oak Grove Cemetery Association recorded in Book 214 Page 292 is specific that 3 acres is to be conveyed. The call along the North side of the property conveyed is 20 rods, the East side 40 rods, the South side 12 rods and the West side 40 rods. 12 rods by 40 rods is exactly 3.0 acres. Also the line of occupancy of the existing East line of the cemetery is approximately 12 rods East of the Northwest corner of the Northeast Duarter of Section 27-22-4. For these reasons we have assumed the deed call of 20 rods to be in error and have used a distance of 12 rods in this survey.
