ORDINANCE NO. 637

AN ORDINANCE ACCEPTING A GIFT OF REAL ESTATE FROM BUSEY BANK OF MCLEAN COUNTY

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have been advised that a gift of real estate from Busey Bank of McLean County is to be made to the City of LeRoy, Illinois, if the City is willing to accept such gift, and so long as such gift is to be used for municipal purposes; and

WHEREAS, the Mayor and City Council of the City of LeRoy have determined that it is in the best interests of the City of LeRoy and of its citizens to accept such gift and to use it in accordance with the conditions requested,

NOW, THEREFORE, BE IT ORDAINED, by the City of Council of the City of LeRoy, in lawful meeting assembled, as follows:

<u>Section 1</u>. That a gift of real estate by Busey Bank of McLean County, said real estate being described as:

That part of Lot 1 of Central Prairies Commercial Park in the City of LeRoy, McLean County, Illinois, described as follows: Beginning at the North East corner of Lot 12 in said Central Prairies Commercial Park; thence North 00 degrees 11 minutes 00 seconds West 139.61 feet to the Northerly Line of the said Lot 1; thence South 48 degrees 54 minutes 00 seconds East 94.93 feet on the Northerly Line of the said Lot 1; thence South 58 degrees 58 minutes 00 seconds East 149.65 feet on the Northerly Line of the said Lot 1 to the most Northeasterly corner of the said Lot 1; thence South 89 degrees 59 minutes 00 seconds West 199.32 feet to the Point of Beginning, in McLean County, Illinois,

has been proposed to be made by deed of gift, a copy of which proposed deed of gift is attached hereto as Exhibit A and incorporated herein by reference. The City of LeRoy hereby accepts said gift of real estate in accordance with the provisions set forth by Busey Bank of McLean County.

<u>Section 2</u>. That the value of said gift has been determined to be \$6,000.00.

Section 3. That said real estate shall be used by the City of LeRoy for municipal purposes, including at the present a site for an emergency alert siren and possibly as a site for the location of a future elevated water tower for the municipal water department.

Section 4. That the City Clerk and City Attorney are hereby directed to take all steps and proceedings as necessary in order to complete the acceptance of said gift, including recording the deed of gift, and obtaining exemption of the property from future real estate taxation.

Section 5. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
