AN ORDINANCE AUTHORIZING THE SALE OF MUNICIPALLY OWNED REAL ESTATE BY THE CITY OF LEROY

WHEREAS, the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, owns the following described real property:

All that part of the West 160 feet of Lot 2 in the Subdivision of the South 1/2 of the Southwest 1/4 of Section 21, Township 22 North, Range 4 East of the Third Principal Meridian lying south of the Conrail corporation Railroad right-of-way except the South 385 feet thereof, and also except the North 10 feet thereof containing an existing public sidewalk, subject to an easement in favor of the City of LeRoy as described in Document No. 94-2505, recorded in the Office of the Recorder of Deeds of McLean County, Illinois, all being situated in the City of LeRoy, County of McLean, and State of Illinois,

which property is generally located South of the Conrail Railroad right of way and East of East Street in the City of LeRoy, and is currently used for sidewalk and municipal open space uses; and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, have determined that it is no longer necessary, appropriate, or required for the use of the City, profitable to the City, or for the best interests of the City of LeRoy, McLean County, Illinois, that said city retain title to the afore described real estate; and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, have determined that sale of the real estate described herein would be in the best interests of the City LeRoy,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

<u>Section 1</u>. Sale of the real estate described as follows:

is hereby authorized to be undertaken, said sale to be made by advertising, as required by statute, for bids, all such bids to be delivered in person or by mail to the City Clerk of the City of LeRoy, at 111 East Center Street, LeRoy, Illinois 61752, at or before 4:30 p.m., August 2, 1996; all such bids to be opened at the regular City Council Meeting on August 5, 1996, at 8:00 p.m., or as soon thereafter as may be possible, and the course of the regular city council meeting to be held on August 5, 1996, and that the corporate authorities then holding office may accept the high bid or any other bid determined to be in the best interests of the city, the acceptance of any such bid to be approved by a vote of 3/4ths of the corporate authorities then holding office. Further, by a majority vote of the corporate authorities then holding office, the city council may reject any and all bids.

Section 2. Notice of the acceptance and opening of bids for the herein described real estate shall be published in the *LeRoy Journal* newspaper with the first publication being not later than July 3, 1996, said notice to be published once each week for three successive weeks.

<u>Section 3</u>. This ordinance shall be in full force and effect upon its passage and approval as required by law.
