AN ORDINANCE PROVIDING FOR THE SALE OF REAL PROPERTY OF THE CITY OF LEROY, MCLEAN COUNTY, ILLINOIS.

WHEREAS, the City of Le Roy, being organized under the laws of the State of Illinois, owns the following described real property:
