# AN ORDINANCE DIRECTING THE SALE OF SURPLUS REAL ESTATE IN THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation owns and holds title to certain vacant real estate which is not being utilized, located within the City of Le Roy, McLean County Illinois, and legally described in Exhibit A, attached hereto and made a part hereof (the "Property"); and

WHEREAS, the corporate authorities hereby determine that the surplus real estate is no longer necessary, appropriate, required for the use of, profitable to, or for the best interest of the City of Le Roy and the City has complied with all relevant provisions of Division 76 of the Illinois Municipal Code, [65 ILCS 5/11-76-1 and 2].

#### NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF LE ROY, McLEAN COUNTY ILLINOIS, AS FOLLOWS:

Ordinance NO. 10-10-01-80 SECTION I. verbiage, "The bids will be received, considered and opened at the regular City Council meeting to be held at City Hall on December 6, 2010, at 7:15 p.m.", is hereby replaced as follows:

**SECTION I.** The real estate hereinbefore described, which is not currently being utilized for any purpose, shall be sold for cash. The bids will be received and opened at Le Roy City Hall on December 20, 2010, at 6:45p.m.

Ordinance NO. 10-10-01-80 Section II. Verbiage, "The first publication shall be on or before October 27, 2010." Is hereby replaced as follows:

**SECTION II.:** The City Clerk shall publish once each week for three (3) consecutive weeks in a daily or weekly paper published in the City of Le Roy, or if none, then in some paper published in McLean County, Illinois, notice of this proposal to sell the real estate. The first publication shall be on or before November 24, 2010. Such notice shall contain an accurate description of the property, state the purpose for which it is used and at what meeting the bids will be considered and opened, and shall advertise for bids therefor and shall be substantially in the form attached hereto marked as Exhibit "A" and made a part hereof.

**SECTION III.** This Ordinance shall be in full force and effect from and after its passage, approval and publication in the manner as provided by law.
