AN ORDINANCE DIRECTING THE SALE OF SURPLUS REAL ESTATE IN THE CITY OF LEROY, MCLEAN COUNTY, ILLINOIS

WHEREAS, the City of LeRoy owns the following described real estate:

Lots 5, 6 and 7 in Block 17 in the Original Town of LeRoy, according to the Plat thereof recorded in Plat Book 3 on Page 544 in the McLean County Recorder of Deeds Office; ALSO all of Lots 1 and 2 in Block 24 in said Original Town of LeRoy; ALSO all that part of vacated Pine Street in said Original Town of LeRoy bounded on the North by the south line of Lots 5, 6, 7 and 8 in Block 17 of said Original Town, bounded on the South by the north line of Lots 1, 2, 3 and 4 of Block 24 in said Original Town, bounded on the East by the west right of way line of East Street and bounded on the West by the east right of way line of Chestnut Street, EXCEPT the N1/2 of vacated Pine Street adjoining said Lot 8 in Block 17, all in the W1/2 of the SW1/4 of Section 21, Township 22 North, Range 4 East of the Third Principal Meridian, City of LeRoy, McLean County, Illinois; and

WHEREAS, the City has determined the foregoing described real estate is surplus, the City having no use or need for the property, and;

WHEREAS, the City of LeRoy finds it is in the best interest of the City to sell the surplus real estate in accordance with 65 ILCS 5/11-76-4.1.

NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF LE ROY, MCLEAN COUNTY, ILLINOIS, AS FOLLOWS:

- 1. The value of the real estate to be sold, as determined by an MAI Certified Appraiser for the State of Illinois, or a licensed Real Estate Appraiser is \$36,000.00.
- 2. The parcel of real estate described herein is zoned C-1-Central Commercial, and the size of the real estate described herein is 1.29 acres. Further, the use of the property described is a grassy area and asphalt parking lot.
- 3. The City of Leroy shall sell the following described real estate:

of Block 24 in said Original Town, bounded on the East by the west right of way line of East Street and bounded on the West by the east right of way line of Chestnut Street, EXCEPT the N1/2 of vacated Pine Street adjoining said Lot 8 in Block 17, all in the W1/2 of the SW1/4 of Section 21, Township 22 North, Range 4 East of the Third Principal Meridian, City of LeRoy, McLean County, Illinois;

by bid to be received after publication and accepted by the City Council by a two-thirds vote of those holding office at a sale price of no less than 80% of its appraised value. Said sale to be made by the Mayor who is authorized to execute any and all contracts for sale and real estate transfer documents necessary for the sale of real estate to be sold herein.

- 4. That the Clerk of this City is directed to place for public inspection the appraisal for the real estate to be sold and to publish this Ordinance at the first opportunity following its passage in a newspaper published in the municipality or, if none, then in a newspaper published in the County where the municipality is located.
- 5. The City is authorized to sell the real estate by accepting a bid or offer from any individual or entity after the publication by a vote of two-thirds of the corporate authorities then holding office at a price no less than 80% of its appraised value.
