ORDINANCE NO. 781

AN ORDINANCE AMENDING ORDINANCE NO. 778, HAVING BEEN AN ORDINANCE PROVIDING FOR THE IMPOSITION AND COLLECTION OF A TELECOMMUNICATION INFRASTRUCTURE MAINTENANCE FEE FOR THE CITY OF LEROY, McLEAN COUNTY, ILLINOIS

WHEREAS, the City of LeRoy (hereinafter referred to as "CITY") is a municipality in accordance with the Constitution of the State of Illinois of 1970; and

WHEREAS, CITY has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and that protect the public health, safety and welfare of its citizens; and

WHEREAS, CITY adopted Ordinance No. 778 on December 15, 1997, said ordinance imposing a fee to replace the CITY's then existing municipal franchise fees with respect to telecommunications retailers; and

WHEREAS, CITY included a footnote under Section 3 of the aforesaid ordinance, found on page 4 of Ordinance No. 778, which footnote may create the impression that CITY intended to impose a fee of less than 1% of all gross charges charged by the telecommunications retailer to service addressed within CITY for telecommunications originating or received in CITY,

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. Recitals. The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

Section 2. Section 3(a) of Ordinance No. 778 contains a footnote numbered 1, which footnote reads as follows:

¹Fee may be imposed in quarter percent increments of not more than 1.0%.

Said footnote is hereby deleted as is the reference to the footnote, being the number "1" found after the percent sign in the second line of Section 3(a).

<u>Section 3</u>. In all other respects said Ordinance and the fee imposed thereby shall continue in full force and effect.

<u>Section 4</u>. <u>Severability</u>. If any section, subsection, sentence, clause, phrase or portion of this Article is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

<u>Section 5.</u> Conflict. This Article supersedes all articles and chapters or parts of articles and chapters adopted prior hereto which are in conflict herewith, to the extent of such conflict.

<u>Section 6</u>. <u>Effective Date</u>. This Ordinance shall take effect immediately upon its passage, approval, and publication in pamphlet form.
