### ORDINANCE NO. 484

# AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF PERSONAL PROPERTY OF THE CITY OF LE ROY

WHEREAS, the City of Le Roy, being a city organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of three-fourths of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said city; and

WHEREAS, a three-fourths or more majority of the corporate authorities then holding office at a regular meeting held at 7:30 P.M., on March 1, 1993, did make the aforesaid determination:

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Le Roy, Illinois, in lawful meeting assembled:

- Section 1. That those items or property listed on the attached schedule A, which schedule is incorporated herein by reference, be sold by the City of Le Roy, by notice published in the local newspapers advertising the sale of the property soliciting sealed bids to be received no later than 7:00 P.M., March 15 , 1993, at the City Hall in Le Roy, Illinois, which will be opened at 7:00 , at the regular City Council meeting on that date, and at which time anyone present who shall have submitted a sealed bid as to any one or more items of property as listed on the attached Schedule A may verbally increase his bid on an item for which his bid was placed.
- Section 2. That the City of Le Roy shall have the right to refuse any and all bids.
- Section 3. That such sale as to each item sold shall be effective with the highest bid to be awarded the sale of the equipment. Terms: Cash upon notice of successful bid, cash payment to be made at the City Hall not later than 4:00 P.M., March 19 , 1993.
- Section 4. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
