ORDINANCE NO. 646

AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF PERSONAL PROPERTY OF THE CITY OF LEROY, MCLEAN COUNTY, ILLINOIS

WHEREAS, the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, is a city organized under the laws of the State of Illinois and having less than 500,000 population; and

WHEREAS, the City of LeRoy owns personal property (a sewer vacuum truck described as follows: 1974 Ford, Model No. CT800, Vehicle ID No. L80FVU15040)which in the opinion of a simple majority of the corporate authorities now holding office is no longer necessary or useful to, or for the best interests of, the City;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. The 1974 Ford Sewer Vacuum Truck is no longer necessary or useful to, or for the best interests of, the City of LeRoy or its residents, and the City has received an offer to purchase said personal property for the price of \$12,500.00, said offer being made by the Village of Creve Coeur, Hills County, Illinois;

Section 2. The Mayor and City Council find that the aforesaid price offered for the 1974 Ford Sewer Vacuum Truck is a fair price.

Section 3. The offer to purchase the 1974 Ford Sewer Vacuum Truck by the Village of Creve Coeur in the amount of \$12,500.00 is hereby accepted. Delivery of the aforesaid vehicle shall be made free on board the Village of Creve Coeur, Illinois, not earlier than January 3, 1996, and not later than January 31, 1996, and upon payment to the City of the purchase price in full. Further, the City sewer department shall provide a driver to deliver the truck to the Village of Creve

Coeur and to provide the said village with one day of training in the use of the aforesaid equipment.

<u>Section 4</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
