AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF PERSONAL PROPERTY OF THE CITY OF LEROY, MC LEAN COUNTY, ILLINOIS.

WHEREAS, the City of LeRoy, being organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of a simple majority of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said City; and

WHEREAS, a majority of the corporate authorities now holding office at a regular meeting held at 7:00 p.m. on January 4, 1999, did make the aforesaid determination,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled:

Section 1: The 1994 Ford Crown P.I. police squad car, VIN 2FALP71W3RX139192, be sold by the City of LeRoy as follows: the City Clerk and City Police Chief shall cooperatively place ads in newspapers of local circulation advertising said personal property for sale and requesting sealed bids be delivered to the City Clerk by 7:00 p.m., Monday, 7, 1999, at which time said bids shall be opened; any one present having submitted a bid shall have the right to raise same. At the conclusion of the bidding, as declared by motion of the City Council, the council may reject all bids or may declare the item sold to the highest responsible bidder. The property shall be turned over to the bidder upon payment in full of the purchase price. Before offering said vehicle for sale, appropriate city officials shall cause all police equipment, including police lights, siren, "cage," and two-way radio to be removed from the vehicle.
