ORDINANCE NO. 03-02-01-80

AN ORDINANCE AUTHORIZING THE SALE OF PERSONAL PROPERTY OWNED BY THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS

WHEREAS, the City of Le Roy, being organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of a simple majority of the corporate authorities now holding office is no longer necessary or useful to, or for the best interests of said City; and

WHEREAS, said personal property is described as follows:

- 1. One 1984 International Dump Truck S1900 Series, VIN # 1HTLDTVR4HA59884;
- 2. One 1993 Chevrolet Caprice police vehicle, VIN # 1G1BL5377PW142917;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled:

- Section 1. Pursuant to Section 11-76-4 of the Illinois Municipal Code, 65 ILCS 5/11-76-4, the City Council of the City of Le Roy, Illinois finds that the following described personal property now owned by the City is no longer necessary or useful to the City and that the best interests of the City will be served by its sale:
 - 1) One 1984 International Dump Truck S1900 Series, VIN # 1HTLDTVR4HA59884;
 - 2) One 1993 Chevrolet Caprice police vehicle, VIN # 1G1BL5377PW142917.

Section 2. The 1984 International Dump Truck S1900 Series and the 1993 Chevrolet Caprice described in Section 1 of this Ordinance shall be sold by the City of Le Roy as follows: the City Clerk shall place an ad in the Le Roy Journal advertising said personal property for sale and requesting sealed bids be delivered to the City Clerk by 2:00 p.m. on Friday, February 14, 2003, at which time said bids shall be opened. Final bids will be delivered to the City Council at their regular meeting to be held on Monday, February 17, 2003. The City Council may by motion passed at said meeting or any subsequent meeting reject all bids, with or without requiring further advertisement, or may declare the vehicles sold to any bidder upon payment in full of the accepted bid to the City. Before offering said vehicles for sale, the appropriate city officials shall cause all city property and police equipment, including but not limited to all police lights, sirens, cages, two-way radios, and video cameras, to be removed from said vehicles.

Section 3. Upon payment in full of the accepted bid(s) to the City of Le Roy, the Mayor of the City of Le Roy is hereby authorized and directed to execute any and all documents necessary to effectuate the sale(s) authorized by this Ordinance.

Section 4. This Ordinance shall be in full force and effect from and after its passage,

approval and publication in pamphlet form as required by law.
