AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF PERSONAL PROPERTY OF THE CITY OF LE ROY, MCLEAN COUNTY, ILLINOIS

WHEREAS, The City of Le Roy, being organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of a simple majority of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said City; and

Whereas a majority of corporate authorities now holding office at a regular meeting held at 7:00p.m., on August 6, 2007, did make and aforesaid determination.

Now, Therefore, Be It Ordained, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled:
