### AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF PERSONAL PROPERTY OF THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled:

Section 1. The 1993 Ford Crown Victoria with vehicle identification number 2FACP71W5PX179464, 1959 Generator Set with trailer 5 KW 60 Cycle, 1960 Generator Set with trailer 5 KW 60 Cycle, Generator Set with trailer Wisconsin Motor Company 4 cylinder air cooled 84 cubic inch gasoline engine, and 2001 Ford Crown Victoria with vehicle identification number 2FAFP71W41X159002, the City Clerk shall place an ad in the Le Roy Journal detailing the process for selling the above described items.
