## AN ORDINANCE APPROVING FINAL SUBDIVISION PLAT FOR "PLEASANT VALLEY SUBDIVISION FIRST ADDITION" TO THE CITY OF LEROY, MC LEAN COUNTY, ILLINOIS.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

- <u>Section 1</u>. That the final plat of Pleasant Valley Subdivision First Addition to the City of LeRoy, a copy of which is attached hereto as Exhibit A, and incorporated herein by reference, is hereby approved.
- <u>Section 2</u>. The Mayor and City Clerk are hereby directed to execute all necessary documents and certificates as may be appropriate in order to evidence the approval by the City of LeRoy of the aforesaid proposed final plat, and to cause and direct the developer to record said final plat promptly. Upon recording the same the developer shall provide copies of said recorded plat as may be appropriate to the City for record purposes.
- <u>Section 3.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication, as required by law.
