ORDINANCE NO. 848

AN ORDINANCE EXTENDING EXPIRATION DATE OF IRREVOCABLE LETTER OF CREDIT FOR MARSH DEVELOPMENT CORPORATION/FALCON RIDGE SUBDIVISION

WHEREAS, the City Council of the City of LeRoy approved and accepted an Irrevocable Letter of Credit, Number 537, issued by Busey Bank - LeRoy, Illinois, on behalf of Marsh Development Corporation, dated June 17, 1996, which Letter of Credit was due to expire June 17, 1998; and

WHEREAS, the aforesaid Letter of Credit was issued in regard to the Falcon Ridge Subdivision Project currently being undertaken by Marsh Development Corporation, as developer; and

WHEREAS, the City Council of the City of LeRoy approved an extension of the due date of the Irrevocable Letter of Credit, Number 537, issued by Busey Bank - LeRoy, Illinois, on behalf of Marsh Development Corporation, said extension having been dated March 6, 1998, which Letter of Credit, as extended, was due to expire October 1, 1998; and

WHEREAS, the City Council of the City of LeRoy approved a further extension of the due date of the aforesaid Irrevocable Letter of Credit, Number 537, issued by Busey Bank - LeRoy, Illinois, on behalf of Marsh Development Corporation, said extension having been dated September 21, 1998, which letter of credit, as extended, is due to expire July 17, 1999; and

WHEREAS, the City of LeRoy and Marsh Development corporation have agreed that certain public improvements required to be completed in connection with the final plat of said subdivision, and an Annexation Agreement entered into between the City and Marsh Development Corporation are not completed at this time and are not anticipated to be completed by July 17, 1999; and

WHEREAS the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that an additional extension of the date by which completion of the various public improvements as contemplated in the aforesaid final plat should be extended,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

- Section 1. The Mayor and City Council of the City of LeRoy hereby find that substantial portions of the various public improvements required in the Falcon Ridge Subdivision, as set forth in the final plat of said subdivision previously accepted by the City Council of the City of LeRoy have been completed, but that certain public improvements remain to be completed, those improvements being laying down of the bituminous surface course on the roadways throughout the platted subdivision, sidewalk work, and tough-up seeding, and that the cost of said public improvements is not expected to exceed \$30,754.00, and that it is in the best interests of the City, its resident, and of the developer, that the Irrevocable Letter of Credit, Number 537, previously issued by Busey Bank LeRoy, Illinois, dated June 17, 1996, and due to expire July 17, 1999, be extended to October 15, 1999.
- Section 2. The City of LeRoy hereby agrees to the Amendment of Irrevocable Standby Letter of Credit No. 537 by extension of expiration date of said Letter to October 15, 1999.
- <u>Section 3</u>. A copy of the aforesaid Amendment to the Irrevocable Standby Letter of Credit No. 537 is set forth as Exhibit A, attached to this ordinance and incorporated herein by reference.
- <u>Section 4.</u> All ordinances, or parts thereof, and all resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.
- Section 5. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or any liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 4 of this ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.
- Section 6. This ordinance shall be in full force and effect from and after its approval, passage and publication in pamphlet form as required by law.
