AN ORDINANCE VACATING PORTIONS OF PLATTED EASEMENTS IN FOX RUN SUBDIVISION, A PLATTED SUBDIVISION IN THE CITY OF LE ROY, MCLEAN COUNTY, ILLINOIS

WHEREAS, a request has been received from the owner of property consisting of Lots 1&2 in Fox Run Subdivision of the City of Le Roy, requesting vacation of platted utility easements as shown on the plat of the aforesaid subdivision; and

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, find that it is in the public's best interest to vacate the portions of said easements as hereinafter described, as said easements would otherwise present an impediment to the development of the aforedescribed lots,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. The easements as hereinafter described in this section are no longer required for the use of public utilities in connection with the development of the lots hereinafter described in Fox Run Subdivision, a subdivision platted in the City of Le Roy, McLean County, Illinois, and the interests of the owners of said lots as well as the public's interests will be subserved by vacating the portions of those easements as described hereafter. The easement intended to be vacated in accordance with this ordinance are legally described as follows:

A part of Lot 2 in Fox Run Subdivision, according to the Plat thereof recorded as Document No. 2006-18173 in the McLean County Recorder Deeds Office, in the SW1/4 of Section 28, Township 22 North, Range 4 East of the Third Principal Meridian, City of Le Roy, McLean County, Illinois, being a strip of land 20 feet of even width lying 10 feet on each side of the following described centerline to wit: Commencing at the southwest corner of Lot 2 in Fox Run Subdivision; thence N.00-00'-00" E. 20.00 feet on the west line of said Lot 2 to the Point of Beginning; thence N.89-50'-00" E 728.08 feet parallel with the south line of said Lot 2 to a point lying 85.00 feet West of the east line of said Lot 2; thence N. 15-05'-31" E 144.03 feet to a point lying 47.5 feet west of the east line of said Lot 2; thence N. 00-00'-00" E. 66.05 feet parallel with the east line of said Lot 2 to the Point of Termination, with assumed bearing given for description purposes only.

Section 2. Vacation of the public utility's interest and of the public's interests in the aforesaid portions of the easements described herein shall not abridge or destroy the right or privileges of any other proprietor or property shown on the final plat of said subdivision. Said vacation does not constitute a closing or obstruction of any easement currently used by any public utility, and, for that reason, and only to the extent that said final plat conflicts with provisions of this vacation ordinance, the final plat of the

aforesaid Fox Run Subdivision to the City of Le Roy, McLean County, Illinois, shall be and the same is hereby vacated.

Section 3. A certified copy of this ordinance shall be filed by the City Clerk of Le Roy, Illinois, for recording in the Office of Recorder of Deeds in McLean County, Illinois.

<u>Section 4.</u> This ordinance shall be in full force and effect form and after its passage, approval and publication in pamphlet form as required by law, and upon the fulfillment of the conditions set forth previously herein.




EASEMENT VACATION PLAT
