The regular council meeting was called to order at 7:01 PM at Le Roy City Hall, 207 S. East Street.

The council entered discussion regarding proposed ordinance 17-05-02-70, an ordinance amending the city code of the city of Le Roy to establish property regulations and priority lien procedures for vacant and unoccupied buildings. The ordinance was drafted to address vacant storefronts in the downtown area. Officer Taylor is reviewing the ordinance and will give his input. Dave stated that legal would attend a council meeting as well to discuss and answer questions regarding the proposed ordinance. Kathleen Field Orr would be attending a future meeting to discuss the implementation of a Business District or TIF district.

In Old and New Business Greg and Dawn asked about the status of the Rusty Hinge.

Greg said that with council approval he would like to form a committee to move forward with plans to attract new business to Le Roy.

Dawn asked about the status of the former Hardees building. Dave said it is currently in the court process.

Greg asked about the status of the City owned old fire department building. Dave said the parapet could be installed at any time and he would be meeting with architects regarding the interior reconstruction.

Dawn expressed concerns regarding the reduced visibility due to a bush North of the exit from the new Casey's onto Chestnut Street.
