

## MINUTES OF THE REGULAR COUNCIL MEETING HELD FEBRUARY 12, 2018

The meeting was called to order at 7:00 PM at Le Roy City hall, 207 S. East Street with all council members present at roll call.

Staff members present were Chief Williamson, Dean Buhrke, Dave Jenkins and Vicki Moreland.

Included on the consent agenda were meeting minutes from January 15, 2018, invoices from January 17, 2018 and February 5, 2018 in the amount of \$71,085.75, and payroll expenses for the period of January 19, 2018 totaling \$43,781.94 and February 5, 2018 totaling \$38,404.52. Motion was made by Dawn and seconded by Hilary for approval of the consent agenda. Chief Williamson reported to the Council that the K-9 program had been suspended, therefore the presentation of a donation from Mikel Petro of McDonalds to the Le Roy Police department in support of the K-9 program was cancelled. The Police will work with the County and other department K-9 units for school checks and drug control.

**Ordinance No. 18-02-01-60,** An Ordinance Modifying The Pay Schedule For Elected Officials, Officers And Employees Of the City Of Le Roy, Mc Lean County, Illinois was passed on a motion made by Dawn and seconded by Glenn.
