SUPPLEMENTAL ANNUAL APPROPRIATION ORDINANCE NO. 176 FOR THE CITY OF LEROY, ILLINOIS 1982 - 1983

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of said city to make substantial repairs to city sheds used for housing city street and sewer department vehicles, and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, have determined that city funds are not presently available for the execution of said project, although city revenues will be sufficient to fund said project in the future, and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, have determined that additional funds are presently available, having been appropriated for a sinking fund for replacement of the city garbage truck, as noted under "II Streets and Sanitation Department, C. Capital Expenditures," of the 1982-1983 city appropriation ordinance,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. That a transfer of funds is hereby ordained to be made from the sinking fund for garbage truck replacement as set forth in Ordinance No. 162, the annual appropriation ordinance for the City of LeRoy, adopted May 17, 1982, to the line item set forth as "II Streets and Sanitation Department, B. Other, For Maintenance and Repair of Buildings for the Department".

Section 2. That such transfer of funds shall be made in the total amount of $\frac{7655.00}{}$

Section 3. That this ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.
