## SUPPLEMENTAL ANNUAL APPROPRIATION ORDINANCE NO. <u>174</u> FOR THE CITY OF LEROY, ILLINOIS 1982 - 1983

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of said city to make substantial repairs to city sheds used for housing city street and sewer department vehicles, and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, have determined that additional revenues of the city will be made available to make the repairs appropriated herein.

NOW, THEREFORE BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. That the ANNUAL APPROPRIATION ORDINANCE NO. 162 FOR THE CITY OF LEROY, ILLINOIS, 1982 - 1983, making appropriations for corporate purposes for the fiscal year beginning May 1, 1982, and ending April 30, 1983, is amended by adding the following under Section 11 Streets and Sanitation Department, Subsection B, "Other", :

"For maintenance and repair of buildings for the dept. ....\$8,000.00"

said appropriation to be made from additional revenues received by the City of LeRoy, in addition to the revenues known and expected to be received by the city of LeRoy at the beginning of the current fiscal year.

Section 2. That the total appropriation under Section 11, B "Other", is hereby amended from \$148,810.00 to \$151,810.00 and that the total appropriation for the Streets and Sanitation Department is hereby amended from \$240,530.00 to \$243,530.00; that the amount appropriated for the expenses of the Streets and Sanitation Department from the General Fund including from the tax for general corporate purposes is hereby increased from \$128,928.00 to \$131,928.00.

Section 3. That the total appropriation for the City of LeRoy is hereby amended to read:

\$1,000,036,964.55 +3,000.00 \$1,000,039,964.55.

Section 4. That this ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.
