FIRST SUPPLEMENTAL ANNUAL APPROPRIATION ORDINANCE FOR THE CITY OF LE ROY, ILLINOIS, 1987-1988

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of said City to transfer funds from the Special Tax Allocation Fund of the City of LeRoy, Illinois, to other funds of the City, and

WHEREAS, revenues in excess of those anticipated for such fund have been received, and

WHEREAS, the corporate authorities of a municipality in the State of Illinois during any fiscal year may adopt a supplemental appropriation ordinance in an amount not in excess of the aggregate of any additional revenue available to the municipality for that fiscal year,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. A supplemental appropriation of municipal revenues of the City of LeRoy is hereby made as follows:

Special Tax Allocation Fund of the City of LeRoy, - Supplemental Appropriations for LeRoy First Tax Increment Finance District - Project and Expenses.

Transfer to reimburse funds under V. Sewer Department Section of Annual Appropriation Ordinance No. 300 for the City of LeRoy, Illinois, 1987-1988, for construction and expansion of sewage collection system from Build Illinois Funds program, for engineering expenses incurred in planning sewer collection system upgrade in TIF District.

Transfer to retirement of bonded indebtedness under V. Sewer Department section of Annual Appropriation Ordinance No. 300 for the City of LeRoy, Illinois, 1987-1988 to holding account for funds to pay bond interest and principal on bonds issued for sewer system expansion, construction approved by special election on March 18,1986.

Section 2. All the aforesaid transfers, including those made in accordance with the appropriation ordinance for the City of LeRoy for fiscal year 1987-1988, from the Special Tax Allocation Fund, are hereby ratified.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as may be required by law.
