#### **ORDINANCE NO. 18-11-03-70**

# AN ORDINANCE AMENDING SECTION 3-4-1 OF THE CITY CODE FOR THE CITY OF LEROY, ILLINOIS – E-CIGARETTES AND ALTERNATIVE NICOTINE PRODUCTS

**WHEREAS**, the City of Le Roy has authority, pursuant to the Illinois Municipal Code, to license businesses and enact regulations promoting public health; and

**WHEREAS**, the City has previously prohibited the possession, sale and use of tobacco products by persons under eighteen (18) years of age; and

**WHEREAS**, alternative nicotine products and E-cigarettes are gaining popularity and being used by persons under eighteen (18) years of age; and

WHEREAS, studies show that the use of these products are harmful to the human body; and

WHEREAS, it is in the best interests of the health, safety and welfare of the citizens of Le Roy to prohibit the sale, use or possession of alternative nicotine products and E-cigarettes within the City of Le Roy, to or by persons under the age of eighteen (18).

**NOW, THEREFORE, BE IT ORDAINED** by the City Council for the City of Le Roy, McLean County, Illinois, as follows:

**SECTION I:** That Section 3-4-1 of the City Code for the City of Le Roy be and the same is hereby amended by adding the following definitions:

Alternative Nicotine Product: A product or device, such as an e-cigarette, not consisting of or containing tobacco that provides for the ingestion into the body of nicotine, whether by chewing, smoking, absorbing, dissolving, inhaling, snorting, sniffing, or by other means. This does not include tobacco products as that term is defined in this section or any product approved by the United States Food and Drug Administration as a non-tobacco product for sale as a tobacco cessation product, a tobacco dependence product, or for other medicinal purposes.

**E-Cigarette:** An Electronic device that typically includes a mouthpiece, a heating element or atomizer, a battery, and electronic circuits; provides a gas derived from a liquid that includes nicotine, propylene glycol, or similar substance and perhaps other substances; and is inhaled by a user in a manner that simulates or resembles smoking. The term "e-cigarette" includes all manner of these devices, regardless of the details of a device's appearance or marketed name, that are manufactured to resemble a cigarette, cigar, pipe, or other smoking or vaping device. The term "e-cigarette" includes the cartridges and components of an e-cigarette, individually or in any combination.

**SECTION II:** That Section 3-4-1 of the City Code of the City of LeRoy be and the same is hereby amended by changing the definition of tobacco products to read as follows:

**Tobacco Products.** Any substance containing tobacco leaf, including but not limited to cigarettes, cigars, pipe tobacco, snuff, chewing tobacco, or dipping tobacco or any alternative nicotine product or any E-cigarette.

**SECTION III:** In Section 3-4-6(a)(1) and (2) be amended to read as follows:

- (a)(1). No minor under eighteen (18) years of age shall buy or possess any tobacco products in any form, unless upon the written order of the minor's parent or guardian.
- (a)(2). No person, including any licensee, shall sell, buy for, distribute samples of or furnish any tobacco products in any of its forms, to any minor under eighteen (18) years of age, unless upon the written order of the minor's parent or guardian, or unless sold in the presence of such parent or guardian.

**SECTION IV:** Any person convicted of violating any provision of this Ordinance shall be fined a minimum amount of Two Hundred (\$200.00) Dollars and not more than Seven Hundred Fifty (\$750.00) Dollars for such offense.

**SECTION V:** All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent and only to the extent they are in conflict herewith.

**SECTION VI:** This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

**SECTION VII:** Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this Ordinance is found to be invalid in any one or more of its several applications, all valid applications shall remain in effect.
