#### ORDINANCE NO. 757

### AN AMENDMENT OF THE ANNUAL APPROPRIATION ORDINANCE 'FOR THE CITY OF LE ROY, ILLINOIS, FOR THE FISCAL YEAR 1997-1998

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City to amend the Annual Appropriation Ordinance for the fiscal year beginning May 1, 1997, and ending April 30, 1998, and

WHEREAS, the City Council of the City of LeRoy passed Ordinance No. 739 on July 21, 1997, being the annual appropriation ordinance for the City for fiscal year '97-'98,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. Item C. under III. Police Department, of the Annual Appropriation Ordinance for the City of LeRoy, Illinois, for fiscal year 1997-98, setting forth an amount of \$20,000.00, which item was appropriated for the purpose of establishing and funding a sinking fund for replacement of squad cars for the police department, is hereby deleted, subject to any necessary funds being considered appropriated to the extent that funds have been approved to be paid out of said sinking fund for the purchase of any police cars or other expenses of the City of LeRoy Police Department through and including October 31, 1997, and said line item is considered, upon adoption of this Ordinance, to then be deleted and of no further effect or consequence.

Section 2. Any amounts not expended under the authority of said appropriation ordinance line item are hereby considered not to be appropriated for any other reason or purpose. In the event the City of LeRoy shall determine it to be necessary to purchase a further police car or other similar equipment for the Police Department of the City of LeRoy, it will be necessary first to adopt a further amended appropriation ordinance.

<u>Section 3</u>. All ordinances, or parts thereof, and all resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.

Section 4. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or any liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 3 of this ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

Section 5. This Ordinance shall be in full force and effect from and after its passage and approval.
