#### ORDINANCE NO. 19-10-01-10

An Ordinance authorizing the City of LeRoy, McLean County, Illinois, to issue Waterworks Revenue Bonds, Sewerage Revenue Bonds, or, in lieu thereof, General Obligation Bonds (Alternate Revenue Source) (said bonds being general obligation bonds to be issued in one or more series, on a taxable or tax-exempt basis, for which property taxes, unlimited as to rate or amount, may be levied, but which are expected to be paid from the net revenues of the waterworks system, the sewerage system and the refuse disposal system of said City) in an aggregate principal amount not to exceed \$5,000,000, for the purpose of paying the costs of improving the waterworks system and the sewerage system of the City.

\* \* \*

WHEREAS, the City of LeRoy, McLean County, Illinois (the "City"), is a duly organized and existing municipality created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code, as amended (the "Municipal Code"), and, having the powers, objects and purposes provided by said Municipal Code, has for many years owned and operated (i) a waterworks system as set forth in Division 129 of Article 11 of the Municipal Code (the "Waterworks System"), (ii) a sewerage system as set forth in Division 141 of Article 11 of the Municipal Code (the "Sewerage System"), and (iii) a refuse disposal system as set forth in Division 19 of Article 11 of the Municipal Code (the "Refuse Disposal System"); and

WHEREAS, the Council of the City (the "Corporate Authorities") has determined that it is advisable, necessary and in the best interests of the City to finance the (i) acquisition, construction, installation and rehabilitation of various capital-related improvements, extensions and facilities of the (a) Waterworks System of the City (the "Water Project"), and (b) Sewerage System of the City (the "Sewer Project"), and related facilities, improvements and costs (the Sewer Project and the Water Project are, collectively, the "Projects"), and (ii) costs of issuance of the Bonds (as such term is hereinafter defined), all for the benefit of the inhabitants of the City; and

WHEREAS, the estimated cost of the Projects, including legal, financial, bond discount, if any, printing and publication costs, capitalized interest, if any, and other expenses (collectively, the "Costs"), will not exceed \$5,000,000, and the City has insufficient funds on hand and lawfully available to pay such Costs; and

WHEREAS, the Corporate Authorities have further determined that it is advisable, necessary and in the best interests of the City that the Projects be constructed and, in order to finance the cost of the Projects it will be necessary for the City to issue bonds payable from the net revenues derived from the operation by the City of the Waterworks System as authorized to be issued at this time pursuant to Division 129 of Article 11 of the Code (the "Water Revenue Bonds"), and the operation by the City of the Sewerage System as authorized to be issued at this

time pursuant to Division 141 of Article 11 of the Code (the "Sewer Revenue Bonds"), or, in lieu thereof, alternate bonds (the "Alternate Bonds"), being general obligation bonds payable from the (i) net revenues of the Waterworks System ("Net Water Revenues"), (ii) net revenues of the Sewerage System ("Net Sewer Revenues"), (iii) net revenues of the Refuse Disposal System ("Net Refuse Disposal Revenues"), (iv) City's distributive share of State of Illinois income taxes ("Revenue Sharing Receipts"), (v) receipts of certain proceeds of the Retailers Occupation Taxes, Service Occupation Taxes, Use Taxes and Service Use Taxes (the "Sales Tax Receipts"), and (vi) City's collection of utility taxes (including any replacement or successor taxes of similar effect) imposed, collected and distributed pursuant to applicable law (the "Utility Tax Receipts," and, together with the Net Water Revenues, the Net Sewer Revenues, the Net Refuse Disposal Revenues, the Revenue Sharing Receipts, and the Sales Tax Receipts, the "Pledged Revenues"), in an amount not to exceed \$5,000,000, as authorized to be issued at this time pursuant to the Act; and

WHEREAS, if the Pledged Revenues are insufficient to pay the Alternate Bonds, ad valorem taxes of the City for which its full faith and credit have been irrevocably pledged, unlimited as to rate or amount (the "Pledged Taxes") are authorized to be extended to pay the principal of and interest on the alternate bonds; and

WHEREAS, up to \$5,000,000 of alternate bonds need to be issued at this time pursuant to the Local Government Debt Reform Act of the State of Illinois, as amended, 30 ILCS 350/1 to 350/18 (the "Act"); and

WHEREAS, pursuant to and in accordance with the provisions of Section 15 of the Act, the City is authorized to issue alternate bonds, in one or more series, on a taxable or tax-exempt basis, in an aggregate principal amount not to exceed \$5,000,000 for the purpose of providing funds for the Projects and to pay the Costs;

NOW THEREFORE, Be It Ordained by the Council of the City of LeRoy, McLean County, Illinois, as follows:

Section 1. <u>Incorporation of Preambles</u>. The Corporate Authorities hereby find that all of the recitals contained in the preambles to this Ordinance are full, true and correct and do incorporate them into this Ordinance by this reference.

Section 2. Determination To Issue Bonds. It is advisable, necessary and in the best interests of the City to construct the Projects for the public health, safety and welfare, in accordance with the estimate of costs as hereinabove described, and that for such purposes, there are hereby authorized to be issued and sold the Water Revenue Bonds, the Sewer Revenue Bonds, or, in lieu thereof, the Alternate Bonds, in an aggregate principal amount not to exceed \$5,000,000.

Section 3. <u>Publication</u>. Within ten (10) days after the adoption of this Ordinance, this Ordinance, together with a notice in the statutory form, shall be published once by the Corporate Authorities in *The LeRoy Leader*, being a newspaper of general circulation within the City, and if a petition, signed by 255 electors (said number being 10% of the registered voters in the City), is filed with the City Clerk within thirty (30) days after the date of the publication, asking that the

question of the issuance of the Water Revenue Bonds (the "Water Revenue Bond Proposition") be submitted to referendum, then the Water Revenue Bond Proposition shall be submitted to the electors of the City at the general primary election to be held on the 17th day of March, 2020, unless there are no voters scheduled to cast votes for any candidates for nomination for, election to or retention in public office, in which case the Water Revenue Bond Proposition shall be submitted to the electors of the City at the general election to be held on the 3rd day of November, 2020. If no petition is filed with the City Clerk within said 30-day period, then this Ordinance shall be in full force and effect and the Water Revenue Bonds shall be authorized to be issued. A petition form shall be provided by the City Clerk at the principal office of the City, located at 207 South East Street, LeRoy, Illinois, to any individual requesting one.

Within ten (10) days after the adoption of this Ordinance, this Ordinance, together with a notice in the statutory form, shall be published once by the Corporate Authorities in *The LeRoy Leader*, being a newspaper of general circulation within the City, and if a petition, signed by 255 electors (said number being 10% of the registered voters in the City), is filed with the City Clerk within thirty (30) days after the date of the publication, asking that the question of the issuance of the Sewer Revenue Bonds (the "Sewer Revenue Bond Proposition") be submitted to referendum, then the Sewer Revenue Bond Proposition shall be submitted to the electors of the City at the general primary election to be held on the 17th day of March, 2020, unless there are no voters scheduled to cast votes for any candidates for nomination for, election to or retention in public office, in which case the Sewer Revenue Bond Proposition shall be submitted to the electors of the City at the general election to be held on the 3rd day of November, 2020. If no petition is filed with the City Clerk within said 30-day period, then this Ordinance shall be in full force and effect and the Sewer Revenue Bonds shall be authorized to be issued. A petition form shall be provided by the City Clerk at the principal office of the City, located at 207 South East Street, LeRoy, Illinois, to any individual requesting one.

This Ordinance, together with a notice in the statutory form, shall be published once by the Corporate Authorities in The LeRoy Leader, being a newspaper of general circulation in the City, and if a petition, signed by 200 electors (said number being the greater of (i) seven and onehalf percent (7½%) of the registered voters in the City or (ii) the lesser of 200 registered voters or 15% of registered voters), asking that the question of the issuance of the Bonds (the "Alternate Bond Proposition") be submitted to the electors of the City, is filed with the City Clerk within thirty (30) days after the date of the publication, then the Alternate Bond Proposition shall be submitted to the electors of the City at the general primary election to be held on the 17th day of March, 2020, unless there are no voters scheduled to cast votes for any candidates for nomination for, election to or retention in public office, in which case the Alternate Bond Proposition shall be submitted to the electors of the City at the general election to be held on the 3rd day of November, 2020. If no petition is filed with the City Clerk within said 30-day period, then this Ordinance shall be in full force and effect and the Bonds shall be authorized to be issued. A petition form shall be provided by the City Clerk at the principal office of the City, located at 207 South East Street, LeRoy, Illinois, to any individual requesting one.

It is expressly provided that in the event that there shall be filed with the City Clerk in a timely manner a petition, asking that the issuance of the Water Revenue Bonds be submitted to

referendum, the Alternate Bonds, payable from Net Water Revenues, shall not be authorized to be issued until such time as the issuance of the Water Revenue Bonds shall have been submitted to the electors of the City and a majority of the votes cast on such question shall have been in favor thereof.

It is expressly provided that in the event that there shall be filed with the City Clerk in a timely manner a petition, asking that the issuance of the Sewer Revenue Bonds be submitted to referendum, the Alternate Bonds, payable from Net Sewer Revenues, shall not be authorized to be issued until such time as the issuance of the Sewer Revenue Bonds shall have been submitted to the electors of the City and a majority of the votes cast on such question shall have been in favor thereof.

Section 4. Additional Ordinances. If no petition with respect to the issue of the Water Revenue Bonds, the Sewer Revenue Bonds, or, in lieu thereof, the Alternate Bonds, and meeting the requirements of applicable law is filed during the petition periods hereinabove referred to, then the Corporate Authorities may adopt additional ordinances or proceedings supplementing or amending this Ordinance providing for the issuance and sale of the Water Revenue Bonds, the Sewer Revenue Bonds, or, in lieu thereof, the Alternate Bonds, and prescribing all the details of the Water Revenue Bonds, the Sewer Revenue Bonds, or, in lieu thereof, the Alternate Bonds, so long as the maximum aggregate principal amount of the Water Revenue Bonds, the Sewer Revenue Bonds, or, in lieu thereof, the Alternate Bonds, as set forth in this Ordinance is not exceeded and there is no material change in the Projects. Such additional ordinances or proceedings shall in all instances become effective in accordance with applicable law. This Ordinance, together with such additional ordinances or proceedings, shall constitute complete authority for the issuance of the Water Revenue Bonds, the Sewer Revenue Bonds, or, in lieu thereof, the Alternate Bonds, under applicable law.

Section 5. Additional Proceedings. If no petition meeting the requirement of applicable law is filed during the petition period hereinabove referred to, then the preparation and distribution of a preliminary official statement relating to the Bonds is hereby approved, and the Mayor is hereby authorized to deem the preliminary official statement nearly final.

Section 6. Severability. If any section, paragraph, clause or provision of this Ordinance shall be held invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the other provisions of this Ordinance.

<u>Section 7.</u> <u>Repealer.</u> All ordinances, resolutions or orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict hereby repealed.

The City will also levy ad valorem property taxes upon all taxable property in the City without limitation as to rate or amount to pay the principal of and interest on the Alternate Bonds. If no petition is filed with the City Clerk within said 30-day period, then this Ordinance shall be in full force and effect and the Sewer Revenue Bonds shall be authorized to be issued.

Notice is hereby further given that if a petition signed by 200 or more electors of the City (being equal to the greater of (i) 7.5% of the registered voters in the City or (ii) 200 of those registered voters or 15% of those registered voters, whichever is less) asking that the issuance of the Alternate Bonds be submitted to referendum is filed with the City Clerk within thirty (30) days after the date of publication of the Ordinance and this notice, an election on the proposition (the "Alternate Bond Proposition") to issue the Alternate Bonds shall be held on the 17th day of March, 2020, unless there are no voters scheduled to

cast votes for any candidates for nomination for, election to or retention in public office, in which case the Alternate Bond Proposition shall be submitted to the electors of the City at the general election to be held on the 3rd day of November, 2020. If no petition is filed with the City Clerk within said 30-day period, then this Ordinance shall be in full force and effect and the Alternate Bonds shall be authorized to be issued.
