ORDINANCE NO. 20-02-02-42

AN ORDINANCE PURSUANT TO TITLE EIGHT, CHAPTER ONE, SECTION SEVEN OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, WATER RATES

WHEREAS, the City of LeRoy, McLean County, Illinois is an Illinois municipal corporation operating in accordance with the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*(hereinafter referred to as "CITY"); and

WHEREAS, the current water rates for the City are below water and sewer rates identified by the U.S. Bureau of Labor Statistics' Consumer Price Index; and

WHEREAS, the Mayor and City Council of the City of Le Roy have determined that it is necessary and beneficial for the citizens of the City of Le Roy to have access to clean water and efficient, effective removal and treatment of waste water; and

WHEREAS, the Mayor and City Council of the City of Le Roy have previously adopted an ordinance providing for increases of water and sewer rates to reflect the changes identified in the Consumer Price Index; and

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, in lawful meeting assembled on Monday, February 17, 2020, as follows:

That pursuant to Title 8, Chapter 1, Section 7, Subsection C, of the Municipal Code of the City of Le Roy, Illinois, the Mayor and City Council make the following changes to the City water rates:

Section 1. After February 1, 2020, the water rates for all residential and business meters within the corporate limits of the City, effective with the first meter reading after February 1, 2020, shall be as follows:

- A. Individual Residences or Businesses:
 - 1. Eight dollars and sixty-five cents (\$8.65) minimum for the first one thousand (1,000) gallons used; and
 - 2. Eight dollars and sixty-five cents (\$8.65) for each one thousand (1,000) gallons beyond the minimum quantity.
- **B.** Multiple Residences or Businesses: the water rates for meters serving more than one single-family unit or more than one business, or combination thereof, shall be:
 - 1. Eight dollars and sixty-five cents (\$8.65) multiplied by the number of individual family units or businesses served from the meter to determine the minimum monthly charge; and
 - 2. Eight dollars and sixty-five cents (\$8.65) for each one thousand

(1,000) gallons beyond the minimum quantity used (as measured through the meter, regardless of the number of individual family units or businesses served from the meter).

Section 2. After February 1, 2020, the water rates for all residential and business meters outside the corporate limits of the City, effective with the first meter reading after February 1, 2020, shall be as follows:

A. A one hundred percent (100%) increase will be added to the above rates for metered customers outside the City's corporate limits.

Section 3. This ordinance shall be in full force and effect following its passage and approval as required by law.
