### ORDINANCE NO. <u>03-06-</u>01-10

### AN ORDINANCE REPEALING CITY OF LEROY ORDINANCE NO. 405

WHEREAS, the City of LeRoy, a municipal corporation, McLean County, Illinois, on July 23, 1991, adopted Ordinance No. 405, which authorized and provided for the issuance of \$450,000.00 in general obligation bonds of the City of LeRoy; and

WHEREAS, said Ordinance No. 405 required the levy of real estate taxes in order to raise the necessary revenues to pay principal and interest on the bonds as due in accordance with the repayment schedule set forth therein; and

WHEREAS, the principal and interest on said general obligation bonds have been fully repaid and there is no need for further levy of the taxes provided for in said Ordinance No. 405.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, McLean County, Illinois, as follows:

Section 1. City of LeRoy Ordinance No. 405 adopted July 23, 1991, shall be and it is hereby repealed and all further property taxes levied thereby are hereby cancelled.

Section 2. The City Clerk is authorized and directed to transmit a certified copy of this Ordinance to the County Clerk of McLean County.

Section 3. This ordinance shall be in full force and effect from and after its passage and approval according to law.
