AN ORDINANCE OF THE CITY OF LEROY, MCLEAN COUNTY, ILLINOIS, AUTHORIZING THE FINAL DISTRIBUTION OF FUNDS IN THE 1st TIF TAX INCREMENT REDEVELOPMENT PROJECT AREA SPECIAL TAX ALLOCATION FUND

WHEREAS, the City of LeRoy (the "City") is a duly organized and validly existing non home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

WHEREAS, pursuant to Ordinance Nos. 219, 220, and 221 adopted on November 5, 1984, as amended by Ordinance Nos. 287 and 288 adopted on December 23, 1986 and Ordinance No. 734 adopted on June 2, 1997, in accordance with the Tax Increment Allocation Redevelopment Act of the State of Illinois, 65 ILCS 5/11-74.4-1, *et seq.*, as from time to time amended (the "*TIF Act*"), the City approved the 1st TIF Tax Increment Redevelopment Project Plan and Project (the "*Plan*"), for a specific area qualifying as a redevelopment project area under the TIF Act (the "*Project Area*"), and adopted tax increment financing for the purpose of implementing the Plan for the Project Area; and,

WHEREAS, in 2012, the Corporate Authorities determined that the designation of the Project Area as a "redevelopment project area" under the TIF Act should be terminated and it was desirable and in the best interests of the City and the taxing districts that the 1st TIF Special Tax Allocation Fund (the "STAF") be dissolved; and,

WHEREAS, certain funds were retained in the STAF to pay all outstanding obligations incurred pursuant to the TIF Act, which has since been done and therefore all funds remaining in the STAF must now be declared "surplus" and paid to the County Treasurer for distribution, pro rata, to the taxing districts as hereinafter provided.

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of LeRoy,

McLean County, Illinois, as follows:

Section 1. The Incorporation of Preambles. The Corporate Authorities hereby find that

all of the recitals contained in the preambles to this Ordinance are true and correct and do hereby

incorporate them into this Ordinance by this reference.

Section 2. Final Distribution of Funds in the Special Tax Allocation. All funds

remaining in the Special Tax Allocation Fund after payment of any attorney fees are hereby

ordered to be paid by the City Treasurer to the County Collector who shall immediately

thereafter pay said funds to the taxing districts in the same manner and proportion as the most

recent distribution by the County Collector to the taxing districts of real property taxes from real

property in the Project Area.

Section 3. Repealer. All ordinances, resolutions, orders or parts thereof, in conflict with

the provisions of this Ordinance be and are hereby repealed.

Section 4. This Ordinance shall be in full force and effect upon its passage and approval,

as provided by law.
