ORDINANCE NO. 20-04-01-40

AN ORDINANCE AMENDING TITLE 4; CHAPTER 2 OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS,

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, has enacted Municipal Code Regulations for the purpose of improving and protecting the public health, safety, comfort, convenience, and general welfare of the people; and

WHEREAS, the Mayor and the City Council have previously enacted a landfill fee to offset the cost of post-closure care of the LeRoy Landfill; and

WHEREAS, the current ordinance fee schedule of three dollars and zero cents (\$3.00) is set to expire May 24, 2020; and

WHEREAS, a contracted engineering firm has forecasted that post-closure care of the LeRoy Landfill will likely go past May 2020; and

WHEREAS, the Mayor and the City Council have determined that it is necessary and in the best interest of the City and its resident that the rates for landfill closure required to be provided by the City be continued, beginning with the first bill prepared after May 24, 2020; and

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled on Monday, April 6, 2020, as follows:

SECTION 1. Title 4 – Public Health and Safety, Chapter 2 – Garbage and Refuse, Section 3 –Landfill Fee shall be amended as follows:

§4-2-3 Landfill Fee.

A. Landfill fee: All utility customers of the City of LeRoy shall pay a <u>three dollar</u> and zero cent (\$3.00) landfill fee per month beginning with the first bill payable in May 2017 and continuing until May 24, 2020 2021.

SECTION 2. Effective Date. This Ordinance shall be in full force and effect from and after its passage and approval and publication as required by law.
