AN ORDINANCE AUTHORIZING THE SALE OF SURPLUS REAL ESTATE

WHEREAS, the City of Le Roy has authority, pursuant to the Illinois Municipal Code, to sell surplus real estate at a price no less than eighty percent (80%) of the appraised value of said property; and

WHEREAS, the City of Le Roy has obtained an Appraisal of certain property herein described by a State Certified or Licensed Real Estate Appraiser indicating the value of the property, subject to this Ordinance; and

WHEREAS, the City Council has determined that the property described herein is no longer necessary appropriate required for the use of, profitable to the use of the City of Le Roy, and is surplus property; and

WHEREAS, the City of Le Roy may, pursuant to the Illinois Municipal Code, sell said property by the City of Le Roy staff, by a licensed Real Estate agency or by public auction following publication of notice of the sale of said property; and

WHEREAS, it is in the best interest of the health, safety and welfare of the citizens of the City of Le Roy to authorize the sale of the property described herein, pursuant to the authority granted by the Illinois Municipal Code (65 ILCS 5/11-17-4.1).

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LE ROY, MCLEAN COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are incorporated herein and form a part of this Ordinance.

- **Section 2.** The City Council for the City of Le Roy finds that the property described in Exhibit A, attached hereto and incorporated herein by reference, is surplus property in that it is no longer necessary, appropriate, required for the use of, or profitable to the City of Le Roy and that said property is surplus property and should be sold by the City of Le Roy.
- **Section 3.** The appraised value of the property described in Exhibit A has been determined pursuant to a written appraisal of a State Certified or licensed Real Estate Appraiser. Said appraisal is marked Exhibit B, attached hereto and incorporated herein by reference.
- **Section 4.** The City Clerk be and is authorized to publish notice in a newspaper of general circulation, within the City of Le Roy, of the sale of the property described in Exhibit A. Such notice shall include the approximate size of the property, the current use and zoning of the property and the terms and conditions of sale.
- Section 5. That the Mayor be and is hereby authorized to negotiate for the sale of said property, and return any offers received for the purchase of said property, to the City Council for its review and consideration. The minimum amount the Council will consider for the sale of the property described in Exhibit A shall be no less than eighty percent (80%) of the appraised value of the property.
- **Section 6.** Publication. The City Clerk be and is hereby authorized and directed to publish this Ordinance in pamphlet form as provided by law.
- **Section 7. Severability.** In the event any part of this Ordinance shall be found and determined to be invalid by a Court of competent jurisdiction, all valid parts that are severable from this invalid parts shall remain in full force and effect.
- **Section 8.** Repealer. All ordinances or parts of ordinances in conflict herein, are hereby repealed, provided, however, that nothing herein contained shall affect any rights, action,

or causes of action, which have accrued to the City of Le Roy, prior to the effective date of this Ordinance.

Section 9. Effective Date. This Ordinance shall be in full force and effect ten (10) days following its publication in pamphlet form as provided by law.
