AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF PERSONAL PROPERTY OF THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS

WHEREAS, the City of Le Roy, being organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of a simple majority of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said City; and

WHEREAS, the City of Le Roy has authority under the Illinois Municipal Code 65 ILCS 5/11-76-4 and the City of Le Roy Code Section 7-6-3; and

WHEREAS, a majority of the corporate authorities now holding office at a regular meeting held at 7:00 p.m., on September 18, 2023, did make and aforesaid determination;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled:

<u>Section 1.</u> The City currently owns a 2015 Ford Explorer, with vehicle identification # 1FM5K8AR4FGA46017, which is no longer necessary or useful to the City and such vehicle is hereby declared surplus property. Final Bids will be delivered to the City Council at their regular meeting to be held on October 16, 2023.

Section 2. The disposition of said vehicle is hereby authorized by competitive bid.

Section 3. The City Administrator is hereby authorized to advertise the sale of said vehicle the 1998 International truck to the bidder submitting the highest bid for the vehicle or otherwise dispose of in a legal manner deemed to be in the best interest of the City of Le Roy.

Section 4. The City Council may accept or reject any and all bids submitted.

<u>Section 5.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
