#### ORDINANCE NO. 24-01-01-51

# AN ORDINANCE AMENDING SECTION 10-10-2 C OF THE ZONING CODE

WHEREAS, the City of Le Roy has authority pursuant to the Illinois Municipal Code, to enact zoning ordinances; and

WHEREAS, the City of Le Roy has enacted a comprehensive zoning ordinance incorporated as Chapter 10 of the City Code of the City of Le Roy; and

WHEREAS, Section 10-10-2 C identifies certain authorized action with regard to nonconforming structures and non-conforming uses within the City of Le Roy; and

WHEREAS, it is in the best interests of the health, safety and welfare of the citizens of the City of Le Roy to amend Section 10-10-2 C in order to permit a non-conforming single family structure to be rebuilt as a legally, non-conforming structure or use, regardless of the amount of damage to such non-conforming structure.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF LE ROY, MCLEAN COUNTY, ILLINOIS, as follows:

**Section 1.** That Section 10-10-2 C of the Le Roy City Code be and the same is hereby amended to read as follows, with strikeouts indicating deletion in text and underscore indicating addition to text:

#### Section 10-10-2 C.

- C. Nonconforming Structures: Where, on the effective date hereof or amendment hereto, a lawful structure exists that could not be built under the regulations and standards of this title as adopted or amended, by reasons of restrictions on lot area, lot coverage, height, yards, spacing between buildings, or other characteristics of the structure or its location on the lot, such structure may be continued so long as it remains otherwise lawful, subject to the following provisions:
- 1. No such structure may be enlarged or altered in a way which increases its nonconformity.

- 2. Should such structure be destroyed by any means to an extent of more than 50% of its replacement cost at the time of destruction, it shall not be reconstructed except in conformity with the provisions of this title. Further provided nonconforming single-family structures are exempt from the regulations regarding damage and destruction of nonconforming uses and can be rebuilt as a legally nonconforming use if any amount of damage occurs.
- 3. Should any such structure be moved for any reason for any distance whatever, it shall thereafter conform to the regulations and standards for the district in which it is located after it is moved.
- **Section 2.** The City Clerk be and is hereby authorized and directed to publish this Ordinance in pamphlet form, as provided by law.
- Section 3. Severability. In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.
- Section 4. Repeal and Savings Clause. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, action, or causes of action which shall have accrued to the City of Le Roy prior to the effective date of this Ordinance.
- **Section 5. Effective Date.** This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
