ORDINANCE NO. 551

AN ORDINANCE AMENDING CHAPTER 42, SECTION 42.06, MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS, 1975 (as amended).

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and of its residents to prohibit the construction and use of barbed wire fences and electrified fences and fence wires, and

WHEREAS, the Mayor and City Council of the City of LeRoy, Illinois, have determined that barbed wire fences, electric fences and electrified wires constitute a safety hazard to the public, to passers by, and to adjoining land owners,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

<u>Section 1</u>. Section 42.06 BARBED WIRE FENCES., Chapter 42, Offenses, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby repealed.

Section 2. New Section 42.06 BARBED WIRE AND ELECTRIC FENCES, of Chapter 42, Offenses, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby adopted in words and figures as follow:

42.06 BARBED WIRE AND ELECTRIC FENCES. It shall be unlawful to erect or maintain anywhere in the City of LeRoy a fence equipped with or having barbed wire, spikes or any similar device, or a fence equipped with or having any electric charge sufficient to cause a shock. An exception to the foregoing prohibited fences shall be security fences topped by barbed wire, so long as the lowest strand of barbed wire is not less than six feet above ground level at any point along the fence, and the City of LeRoy, acting through the Mayor and the City Council, or an agent designated to act on behalf of the Mayor and City Council, has given written consent to the construction and placement of the aforesaid security fence topped by barbed wire.

<u>Section 3.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
