ORDINANCE NO. 570

AN ORDINANCE AMENDING CHAPTER 20-BUILDING, MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is appropriate to provide for regulations regarding construction of fences in the City of LeRoy, and

WHEREAS, Chapter 20 of the Municipal Code of LeRoy, Illinois, 1975 (as amended), presently contains provisions regarding construction of fences,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

<u>Section 1.</u> Section 20.01 <u>DEFINITIONS</u>. and Section 20.02 are hereby re-designated and lettered as subsections (a) and (b), respectively, of Section 20.01 <u>Fences</u> and subsections (a) thru (e) of former Section 20.01 are hereby re-designated and numbered 1. thru 5. of new Section 20.01 Fences.

Section 2. New Section 20.02 POLE BUILDINGS is hereby added (to Chapter 20 - BUILDINGS, Municipal Code of LeRoy, Illinois 1975 (as amended)) in words and figures as follow:

20.02 POLE BUILDINGS.

(a) **DEFINITIONS**:

Pole Building:

Any building constructed with a frame or support infrastructure of wooden or metal poles, or squared dimensional lumber, to which metal or other type of siding is attached.

(b) As of the effective date of this ordinance no pole building shall be built anywhere in the City of LeRoy without permission granted in writing after petition made to the City Council of the City of LeRoy, and a written decision rendered by the City Council.

<u>Section 3</u>. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.
