ORDINANCE NO. <u>587</u>

AN ORDINANCE GRANTING A VARIANCE FROM THE EFFECT OF AND REQUIREMENTS OF ORDINANCES NO. 356 & 363, ALSO FROM THE EFFECTS OF OF CHAPTER 20, BUILDING, OF THE MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (as amended)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, a municipal corporation, have determined that it is in the best interests of the City and its residents that a variance from the effect of Ordinances No. 356 and 363 be granted, and that such variance shall also be a variance from the effects of Chapter 20, Building, Municipal Code of LeRoy, Illinois, 1975 (as amended), and

WHEREAS, upon the letter petition dated March 29, 1995, of Ameritech Mobile Communications, Inc. (AMCI), and Chicago SMSA, a limited partnership, a variance from the requirements of Ordinances No. 356 and 363, and from the requirements of Chapter 20, Building, Municipal Code of LeRoy, Illinois, 1975 (as amended), has been requested as to a fence project,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled as follows:

Section 1. A letter petition has been received dated March 29, 1995, filed with the City Clerk on behalf of Ameritech Mobile Communications, Inc., and on behalf of Chicago SMSA, a limited partnership, a copy of said request being attached hereto as Exhibit A and incorporated herein by reference, said letter petition requesting a variance from the fence requirements of Chapter 20, Building, Municipal Code of LeRoy, Illinois, 1975 (as amended). The variance being requested is to allow the construction of a fence eight (8) feet in height, being a seven (7) foot high chain link fence topped with three (3) strands of barbed wire, constituting an additional one foot. The variances requested, specifically being to permit the construction of an eight (8) foot high fence, being a seven (7) foot high chain link fence and three strands of barbed wire for an additional foot, totaling eight feet in all, and a variance permitting barbed wire to be used within the City whereas the same is otherwise prohibited by ordinance, are hereby granted.

Section 2. The city attorney is hereby directed to forward a letter with a signed copy of this ordinance to the representative of Ameritech Mobile Communications, Inc., and the representative of Chicago SMSA limited partnership, indicating the approval of the City Council for the variance effective the date of this ordinance.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law
